SIGNIFICANT JAIL TERMS FOR SISTERS INVOLVED IN ABUSE OF VICTIM WITH INTELLECTUAL DISABILITY

The Court has imposed a global sentence of 102 months' (eight and a half years) imprisonment on Haslinda Binte Ismail ("**Haslinda**") and 36 months' imprisonment on Hasniza Binte Ismail ("**Hasniza**"). The Court also imposed a compensation order¹ of S\$1,000, in default four days' imprisonment, to be paid by Hasniza to the victim.

Case against Haslinda

2 In submitting for nine and a half years' imprisonment, the Prosecution took into account Haslinda's role in the acts of abuse against the victim. Haslinda had exploited her position of trust and authority in inflicting gratuitous violence, and subjecting the victim to demeaning treatment.

3 The Prosecution did not seek a compensation order as Haslinda was assessed to not have the financial means to pay. She has been certified medically unfit for work and unemployed for more than a year, and her family was on social assistance. Under the law, a compensation order should only be made when an offender has the means to pay compensation within a reasonable time².

Case against Hasniza

4 For Hasniza, in submitting for 39 months' imprisonment, the Prosecution took into account that she was less culpable than Haslinda. None of the injuries found on the victim upon admission to the hospital were attributable to Hasniza.

¹ A compensation order refers to an order made by the court for a person convicted of a criminal offence to pay a sum of money to the victim. The sum of money to be paid will be determined by the court.

5 The compensation ordered against Hasniza was in respect of the injuries to the victim she was responsible for. The amount sought is in line with past cases where victims suffered similar injuries, and the guidance in *Guidelines for the Assessment of General Damages in Personal Injury Cases*, published by the State Courts and the Singapore Academy of Law. The Prosecution did not seek compensation for the victim's medical expenses as they were largely covered by MediFund, and did not arise from Hasniza's acts.

Case against Hasmah

6 Their mother, Hasmah Binte Sulong ("**Hasmah**"), faces the most serious charges. She faces a total of 17 charges, including three counts of voluntarily causing grievous hurt by dangerous weapons or means. The maximum punishment for voluntarily causing grievous hurt by dangerous weapons or means is life imprisonment. The case against Hasmah is still before the Courts.

Annex A

Six individuals, including the sisters, were charged for their involvement in the abuse of the 27-year-old victim with mild intellectual disability. Five of these individuals have pleaded guilty, whilst the case against Hasmah Binte Sulong ("Hasmah") remains before the Court.

Hasmah faces a total of 17 charges, including three counts of voluntarily causing grievous hurt by dangerous weapons or means, four counts of voluntarily causing hurt by dangerous weapons or means, one count of voluntarily causing grievous hurt and two counts of wrongful confinement.
